DELEGATE RELEASE FORM

DESCRIPTION OF ACTIVITY: The Participant will register with the William & Mary International Relations Club (“Club”) and participate in the William & Mary High School Model United Nations Conference (“Conference”). The Participant will attend committee sessions and other events held on the campus of The College of William and Mary (“College”).

LOCATION: College, Williamsburg, Virginia

DATE: November 17, 2017 – November 19, 2017

I, the Participant (or Parent/Guardian if the Participant is a Minor), do certify that I am fully competent to sign this Agreement. I give my permission for the Participant to participate in the above-referenced Conference. I acknowledge that working in this setting may expose the Participant to hazards or risks that may result in the Participant’s illness or personal injury, and I understand and appreciate the nature of such hazards and risks. I recognize that the Participant must abide by all regulations established by the William & Mary High School Model United Nations Conference as set down by its Code of Conduct and the instructions of its staff. The Participant will also abide by all applicable laws and regulations and College policies and procedures. I understand that the Participant’s failure to do so may result in the Participant’s dismissal from the Conference, requiring me to make arrangements for, and to pay all of the costs relating to, the Participant’s departure.

In consideration of the Participant being permitted to participate in the Conference, and recognizing that the Participant is not enrolled at the College nor paying any tuition or fees, I hereby accept all risk to Participant’s health and all risk of his/her injury that may result from such participation, and I hereby release the College, Conference, and Club, including the governing boards, trustees, officers, employees, and representatives from any and all liability to Participant, Participant’s personal representatives, estate, heirs, next of kin, and assigns for any and all claims and causes of action for loss of or damage, to Participant’s property and for any and all illness or injury to Participant’s person that may result from or occur during Participant’s participation in the Conference, whether caused by negligence of the College, Conference and Club, their governing boards, trustees officers, employees, or representatives, or otherwise. I further agree to indemnify and hold harmless College and the governing boards, trustees, officers, employees, and representatives from liability for the injury for any person(s) and damage to property that my result from Participant’s negligent or intentional act or omission while participating in the Conference.

I have been informed and I understand that this event will be videotaped and/or photographs will be taken. As such, I do hereby authorize the William & Mary International Relations Club and those acting pursuant to its authority to photograph or videotape the image, likeness, or depiction of the Participant and use their name, likeness, voice, and/or biographical material in connection with these recordings. I understand that the Club may use such photographs with or without associating names thereto. Exhibition or distribution of such photographs and/or recording will be done in whole or in part without restrictions or limitation for any educational or promotional purpose which the Club and those acting pursuant to its authority deem appropriate. I further waive any claim for compensation of any kind for the Club's use or publication of photographs or video recordings of the Participant.

I hereby fully and forever discharge and release the Club from any claim for damages of any kind (including, but not limited to: invasion of privacy; defamation; false light or misappropriation of name, likeness or image)

arising out of the use or publication of photographs of the Participant by the Club, and covenant and agree not to sue or otherwise initiate legal proceedings against the Club for such use or publication.

I desire that the Participant benefit from the transportation provided by the Club and Conference where necessary to the experience or in situations of emergency. I further understand and agree that transportation is provided by volunteers of the Club ("Volunteers") driving either personally owned vehicles or vans rented from the College. This transportation is provided as a public service. In return for the benefit received, I voluntarily waive any claim based on any injuries that Child may suffer in connection with the transportation, including any injuries caused by the negligence of the Volunteers, the Club, the Conference, the College, or the Commonwealth of Virginia ("Commonwealth"), or any of their agents. Additionally, I will defend, hold harmless, indemnify, release, and forever discharge the Volunteers, the Club, the Conference, the College, and the Commonwealth and all their agents from and against any claim that might result from the transportation provided to Child.

No one makes any express or implied representation to me that the Club or Conference are anything other than independent organizations, legally separate and distinct from the College and Commonwealth. I further understand that no one makes any express or implied representation to me regarding the adequacy or safety of the transportation.

I understand that this waiver binds me, my assigns, my representatives, and my heirs.

I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND IT TO BE A RELEASE OF ALL CLAIMS AND CAUSES OF ACTION FOR PARTICIPANT'S INJURY OR DAMAGE TO PARTICIPANT'S PROPERTY THAT OCCURS WHILE PARTICIPATING IN THE DESCRIBED ACTIVITY. I FURTHER UNDERSTAND THAT THIS AGREEMENT OBLIGATES ME TO INDEMNIFY THE PARTIES NAMED FOR ANY LIABILITY FOR INJURY OF ANY PERSON AND ANY DAMAGE TO PROPERTY CAUSED BY PARTICIPANT'S NEGLIGENT OR INTENTIONAL ACT OR OMISSION.
